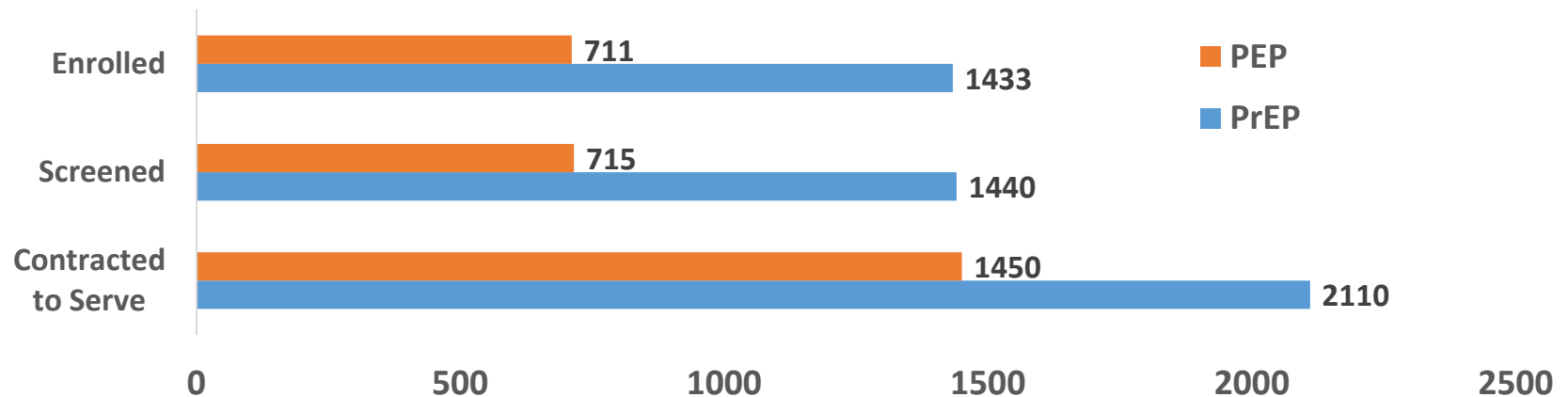


DHSP-Funded Biomedical Prevention Services Enrollment September 30, 2016 - September 29, 2017

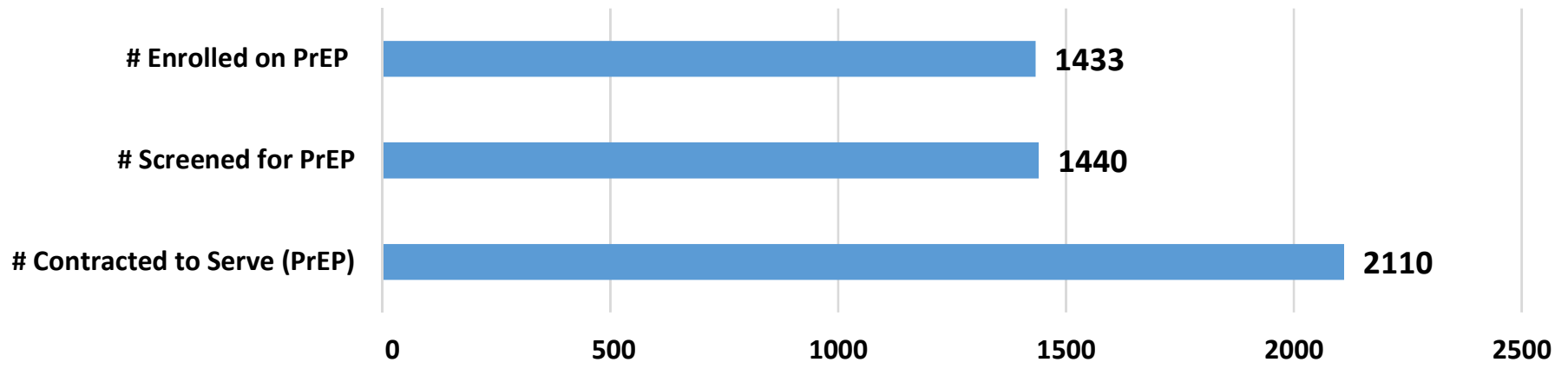
In August of 2016, DHSP funded nine agencies to enhance biomedical HIV prevention services for uninsured and underinsured Los Angeles County Residents. The following dashboards provide enrollment data for clients newly enrolled in biomedical prevention services during the second year of the contract (September 30, 2016 through September 29, 2017) by agency, quarter, and demographic categories. The data are detailed in tables and summarized figures for both PrEP and PEP. Note: These data only reflect clients receiving biomedical prevention services under each agency's contract with DHSP. For example, the dashboards exclude clients who are not new to PrEP and/or PEP during the contract period. Furthermore, the data are not reflective of all persons taking PrEP or PEP in Los Angeles County.



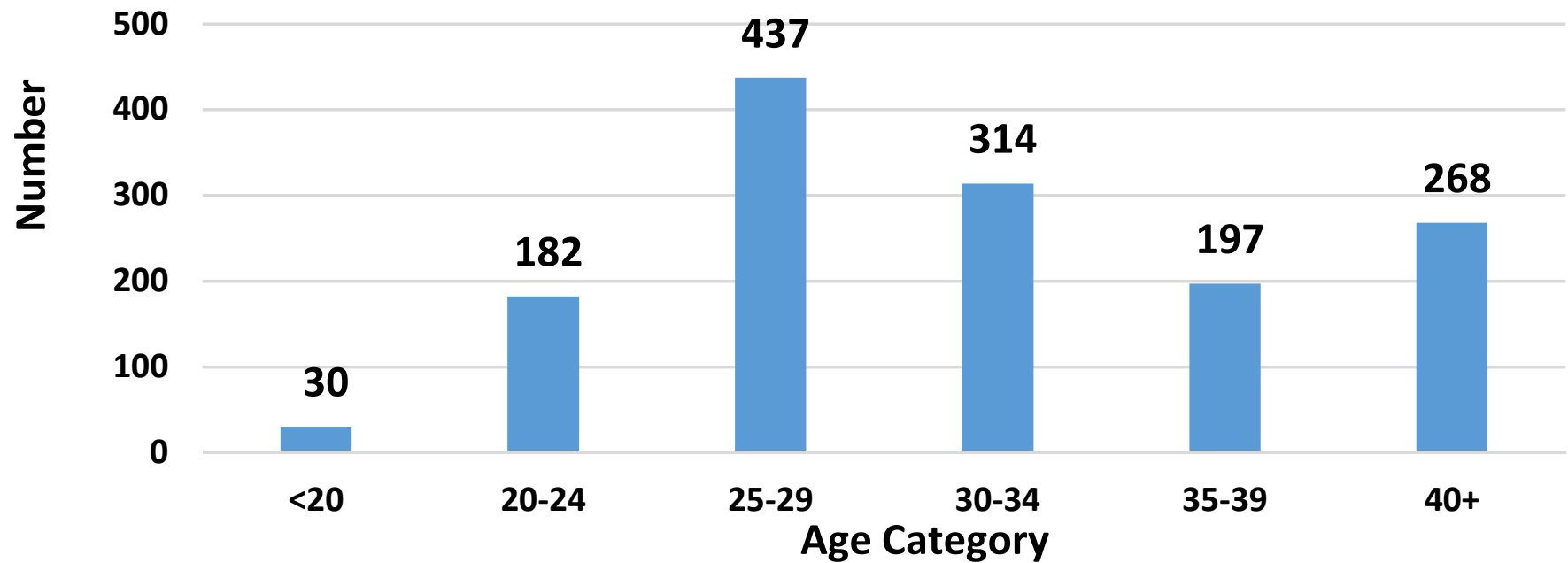

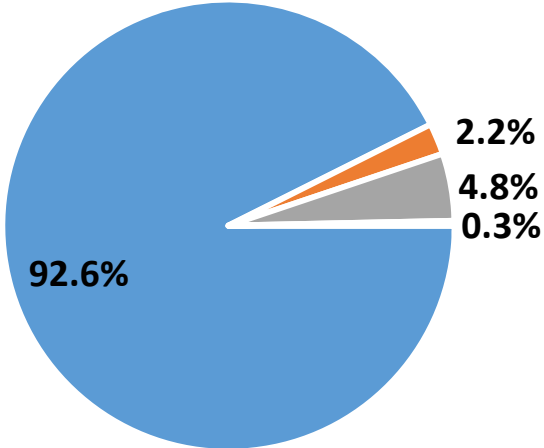
Number of Clients Expected, Screened and Newly Enrolled in DHSP-Funded PrEP Services, Contract Year 2



Number of Clients Newly Enrolled in PrEP Services by Age Category, DHSP-Funded PrEP Services Contract Year 2

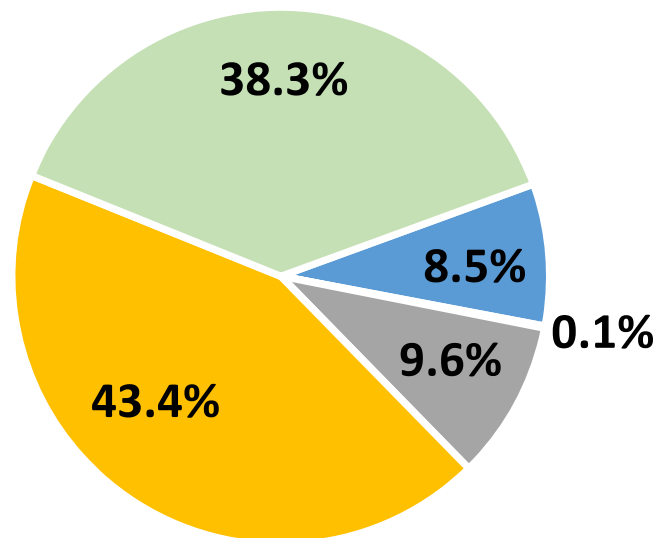


**Proportion of Newly Enrolled PrEP Clients by Gender,

Proportion of Newly Enrolled PrEP Clients by Race/Ethnicity, DHSP-Funded PrEP Services, Contract Year 2



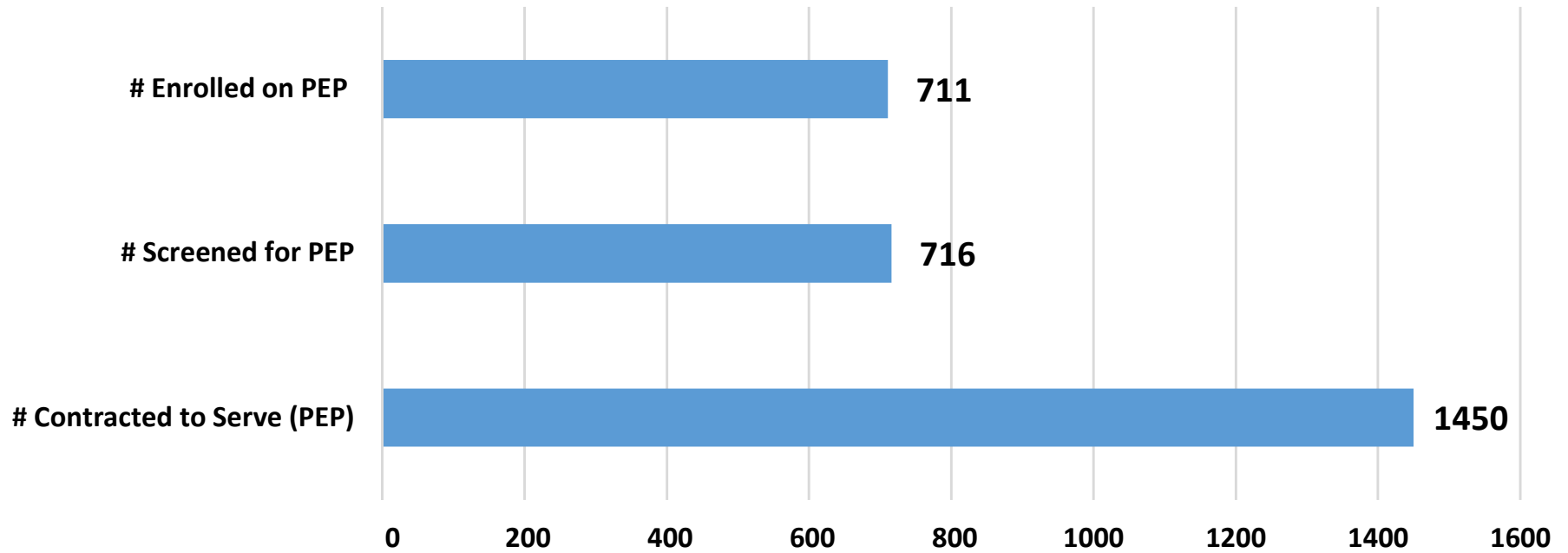

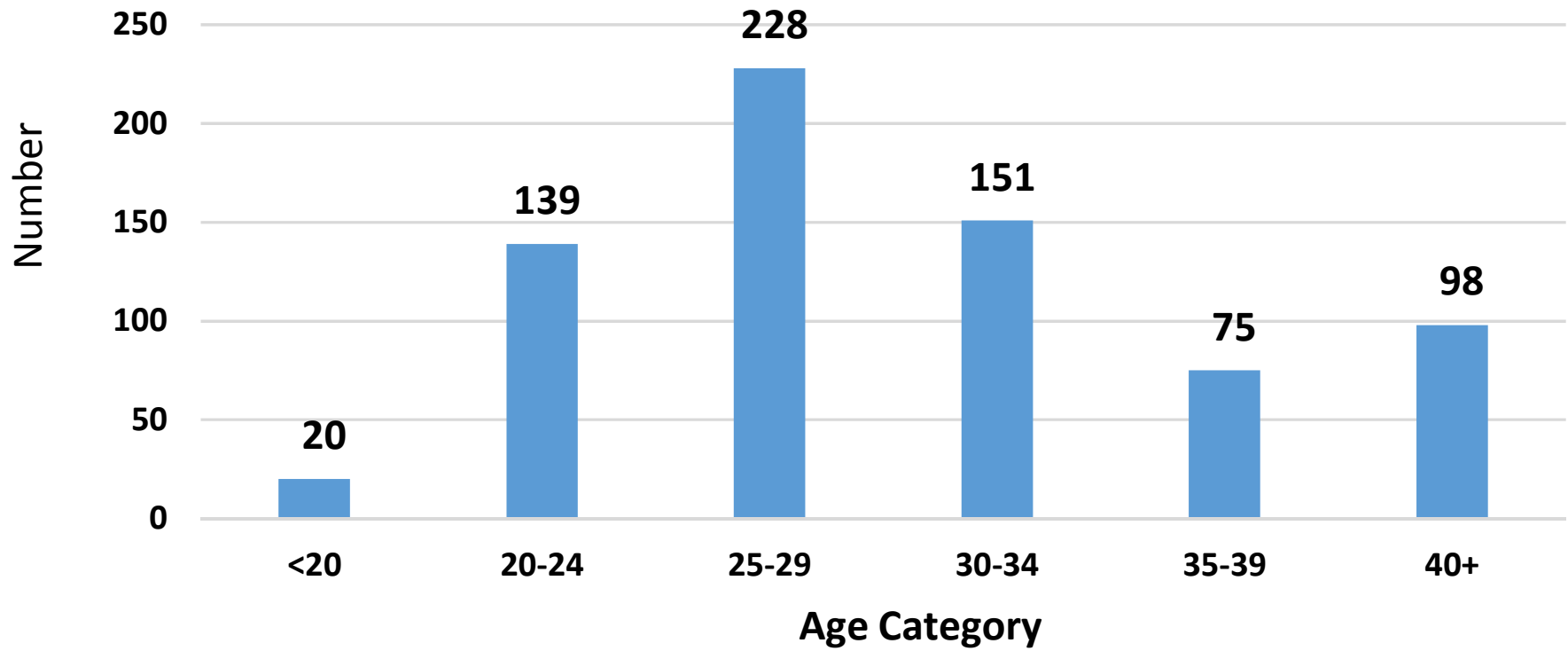

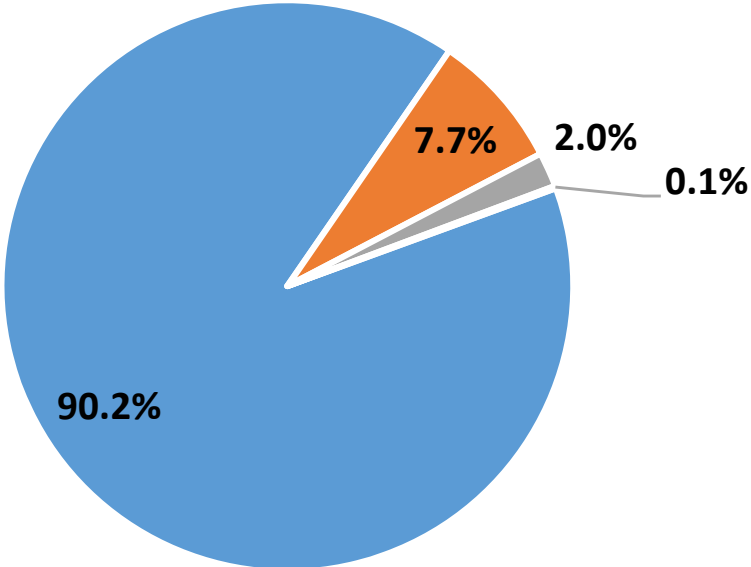
Number of Clients Expected, Screened and Newly Enrolled in DHSP-Funded PEP Services, Contract Year 2

by Age Category, DHSP-Funded PEP Services Contract Year 2**

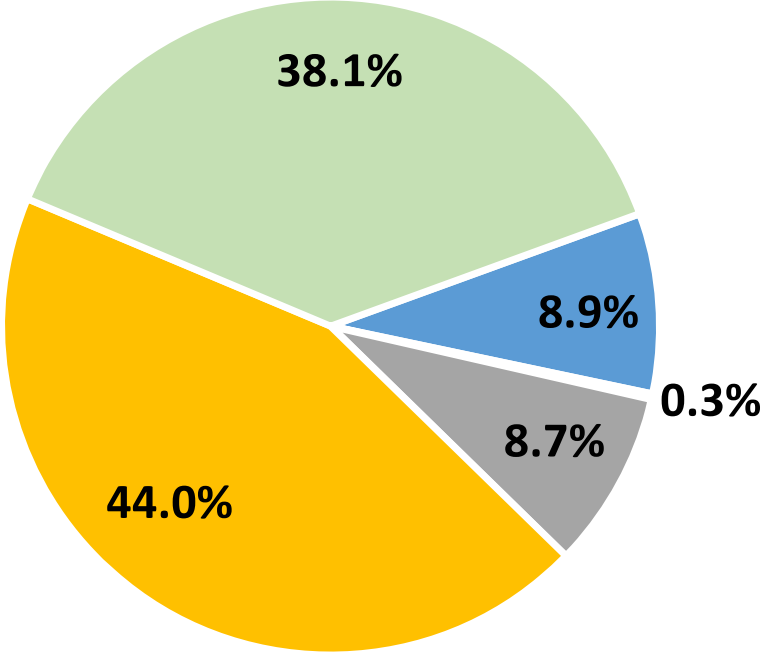


**Proportion of Newly Enrolled PEP Clients by Gender,
