DESCRIPTION:

The Seasonal Influenza Vaccine (Flu) Recommendations in-service will focus on influenza disease information, vaccine indications, adverse reactions, contraindications, vaccine schedule, vaccine administration, and vaccine storage and handling.

OBJECTIVES:

- List the major categories of persons who should be vaccinated with seasonal flu
- Differentiate between the two types of seasonal flu vaccines
- Identify the contraindications and common adverse reactions associated with flu vaccinations
- State the dose and route of seasonal flu vaccine administration
