#### EXAMPLE OF DUTIES:

- Directs, plans and defines nursing administrative methods, procedures, workflows and standards for quality and quantity of work, including staffing standards for the CCS program.
- Oversees direct supervision over the nurse case management section to ensure Federal, State, and County Children's Medical Services (CMS) section policies and procedures are maintained.
- Interprets, develops, and implements CMS practices and procedures in collaboration with the CMS Director, Medical Director, and other CCS management and supervision personnel.
- Determines personnel, material, equipment, and facilities necessary to exceed program goals.
- Advises the planning, development, and implementation of orientation/trainings in alignment with CCS program guidelines for healthcare and community providers and Special Care Centers (SCCs).
- Promotes joint planning among CCS clinical and administrative workforces and collaborates with providers, community organizations, regional centers, the Medical Therapy Program (MTP) and various agencies and institutions.
- Serves as the senior nursing executive supervising a workforce of nurse managers, nurse supervisors, nurses and nurse instructors and specialists, along with management, administrative and technical support.
- Leads CCS Program Continuous Quality Improvement (CQI) activities, integrating best practices and standards of care, and reviewing and updating the nursing case management scope of work.
- Facilitates collaborative healthcare relationships between CCS, children/youth/families, providers, hospitals, SCCs, health plans, school districts, MTP personnel, and community services and resources.

- Inspirational vision that engages staff to improve the health outcomes of children/youth with complex medical needs
- Autonomous and industrious work habits that share the values of compassion, service, equity and quality
- Commitment to transformational change and leadership that supports new insights and perspectives
