Essential Job Functions:

- Provide consultations, resources, joint visitations and skilled nursing observations related to the children's health, nutritional and developmental status as appropriate for children in the child welfare system with known or suspected health problems
- Advocate for the health care needs of the children
- Assist with development of health care plans for the children
- Participate in case conferences including Child and Family Team Decision Making, Critical Incident, Child Fatality Reviews and hospital discharge planning conferences for children in the child welfare system.
- Collaborate and coordinate with medical providers, Hubs and other specialty referrals such as Regional Center and California Children's Services to meet the health care needs of children in the child welfare system.

Requirements:

- A license to practice as a Registered Nurse and a Public Health Nurse Certificate issued by the California Board of Registered Nursing and a valid California Class C Driver License
- Must currently be a permanent Los Angeles County employee who holds the payroll title of Public Health Nurse.

Desirable Qualifications:

- Pediatric experience
- Public Health Nursing field experience
- Knowledge of growth and development of infants, children and adolescents•
- Ability to work independently
