Credentialing Process

- Based on the State of California, Department of Health Services, Mental Health Use Disorder Services (MSHUDS) Information Notice No: 18-019
- Will be incorporated into Sage Onboarding and Personnel Review during the annual monitoring audit
- Designed to leverage existing processes to streamline and minimize effort
- Initial and On-going

Current Sage Onboarding Required Information

- National Provider Identifier (NPI) Number
- Licensed Practitioner of the Healing Arts (LPHA) and Counselor License/Certification Number
- License Effective and Expiration Date
- Drug Enforcement Administration (DEA) License Number
- Date of Hire
- Worksite Location

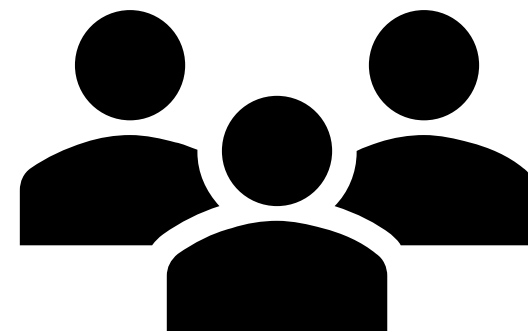

Implementation Timeline

- Credentialing Bulletin 21-03 was released on March 25, 2021
- Credentialing will be incorporated into personnel review beginning FY 2021-22

ACTION ITEMS:

- Begin compiling/confirming information



Contracts Update

Recovery Services Amendment

- Amend contracts to establish Recovery Services as a stand-alone Level of Care
- Currently part of some Levels of Care
- Increase visibility and utilization
- Align with State's structure
- No additional Sage configuration is needed

Contracts Update

Requests for Contract Amendments

- Request must be submitted by end of **APRIL 2021** to allow processing prior to end of fiscal year
- Funding increases & additional services/sites will be based on:
 - **Utilization**: Utilization of at least 75% of contracted amount
 - **Performance**: Compliance with all relevant regulations and resolutions of any non-compliance issues
 - **Need**: Evidence there is a need for the additional service including overall network utilization

- Hand Sanitizers
- Face Shields
- Protective Gowns
- Box Spring Covers
- Air Scrubber
- Electrostatic sprayer
- Air purifier & replacement filter
- 5 gallons of disinfectant
