**NOTICE OF INTENT TO RELEASE A REQUEST FOR STATEMENT OF QUALIFICATIONS FOR THE PROVISION OF SUBSTANCE USE DISORDER SERVICES**

The Department of Public Health (DPH) is releasing a Request for Statement of Qualifications (RFSQ) to establish a pool of qualified vendors that are able to provide as-needed Substance Use Disorder (SUD) services to adult and/or youth populations in the County of Los Angeles.

Interested and qualified agencies/organizations that meet the minimum qualifications of the RFSQ are invited to submit a Statement of Qualifications to qualify in one or more of the following service categories: 1) Outpatient Counseling Services; 2) Day Care Habilitative Services; 3) Outpatient Narcotic Treatment Program Services; 4) Alcohol and Drug Free Living Centers; 5) Residential Treatment Services; 6) Medication Assisted Treatment; and 7) Residential Detoxification Services. All potential Proposers must register in the County's WebVen. The WebVen contains the Vendor's business profile and identifies the goods/services the business provides.
